

## Message to grade 11 students and parents - positive case 11th grade

To all 11th grade students and families

Dear all.

today (12th January ) in the afternoon, an 11th grader tested positive to a rapid antigen test. As per "Ordinanza 26 del 30/12/2021 del Presidente della Regione Lazio" a positivity by rapid antigen test does not need to be confirmed by a molecular test. Close contacts have already been identified and notified.

Given the positive case in the grade, as per decree DL n.1 7/01/2022, the whole grade will be in AUTOSORVEGLIANZA (self-surveillance) until Sunday 23rd January 2022.

During the Autosorveglianza (self-surveillance) period:

- students will need to wear an FFP2 mask at all times inside and outside of school:
- from the 13th January to the 21st January students will need to consume meals by themselves (2 meters apart from others):
- during the first 5 days of Autosorveglianza contact sports and team sports must be avoided (if not schoolrelated, please inform your coach and check with your club);
- during the first 5 days of the Autosorveglianza (until the 17th January) students and teachers will pay particular attention to symptoms like fever, sore throat, runny nose, cough, any gastrointestinal symptoms, body aches, chills, headache and, if they develop any of these symptoms, should immediately test for Covid-19 (a rapid antigen test will be enough) and notify the school at nurse@sssrome.it with the Covid manager in copy fabio.boccuni@sssrome.it . This is really important, as with three positive cases the grade will need to go in remote learning;

Please note that, even if negative, students should be symptom-free for 48 hours before returning to school. If they are absent for 5 or more days (including these 48 hours), a medical certificate for readmission is required by regional laws.
