Dear families,

A student in grade 10 tested positive today. As you are probably aware, this brings the number of positive cases in Grade 10 to two. As per my previous communication, when this happens, there can be two different situations:

- a. Students who received their booster dose or recovered in the past 120 days or have been fully vaccinated in the past 120 days will continue with the "Autosorveglianza"; **Students in this category should continue to come to school.**
- b. Students who are not vaccinated or are vaccinated/recovered from more than 120 days will do remote learning for 10 days; **Students in this category will return on the 24th of January.**

Please note that students in situation **b)** will need to isolate themselves until further instructions from the ASL RM 1, our local health authority. As we have learned before, although we consider our environment safe, the local health authorities might decide to quarantine the class based on the current epidemiological situation and their own risk assessment in light of the latest protocol. In this case, I will let you know immediately. If this happens, a rapid antigen or PCR negative test and a doctor's certificate for readmission will be required to end quarantine.

As the school needs to know the most updated status of your child in relation to Covid, please send a copy of the Green Pass from recovery/vaccination or any other document that shows your child's vaccination status to nurse@sssrome.it no later than tomorrow (13th January) at 8 AM, so that we can process all the information before classes.

This procedure does not apply to students who have been absent for the past three days because they haven't been in contact with the grade yet, but please update your recovery/vaccination documents anyway.
